



# KNOW & EXERCISE YOUR RIGHTS

## DO NOT OPEN THE DOOR

- ASK THE AGENT TO SLIDE THE JUDICIAL WARRANT UNDER THE DOOR OR HOLD IT AGAINST THE WINDOW. MAKE SURE IT'S A VALID JUDICIAL WARRANT.
- A VALID JUDICIAL WARRANT SHOULD HAVE: YOUR CORRECT NAME AND ADDRESS, VALID DATE, AND BE SIGNED BY A JUDGE
- IF THE JUDICIAL WARRANT DOES NOT HAVE THE CORRECT INFORMATION, THEN THE WARRANT IS NOT VALID. SHOW THE AGENT THIS FLYER

## REMAIN SILENT

- DO NOT ANSWER ANY QUESTIONS & SAY: "I WISH TO REMAIN SILENT"
- DO NOT PROVIDE INFORMATION REGARDING WHERE YOU WERE BORN, WHEN, OR HOW YOU ARRIVED TO THE COUNTRY

## SPEAK WITH YOUR ATTORNEY

- SAY "I WILL CALL MY ATTORNEY" AND CALL YOUR ATTORNEY BEFORE ANSWERING ANY QUESTIONS

## DO NOT SIGN ANYTHING

- DO NOT SIGN ANY DOCUMENTS

ORDER FOR WARRANT FOR ENTRY ON PREMISES TO SEARCH FOR ALIENS WHO ARE IN THE UNITED STATES WITHOUT LEGAL AUTHORITY

The United States of America, having filed an application to authorize officers of United States Immigration and Customs without legal authority and, if any such persons are found on the premises to exercise their authority pursuant to section 287 of the Immigration and Nationality Act, 8 U.S.C. § 1357, to question them to determine whether they are such aliens and, if there is probable cause to believe they are such aliens, to arrest them.

IT IS FURTHER ORDERED that U.S. Immigration and Customs Enforcement shall conduct the entry and search during daylight hours with ten (10) days of the issuance of this warrant, and make its return to this Court with ten (10) days of the date the entry and search have been completed.
